CRITERIA FOR APPLICANTS/RECIPIENTS

Consideration is given to Applicants who:

- **Live or work in the Kualoa-He'eia area;**
- Legal resident of the State of Hawaii;
- Accepted for admission:
 - At a two year community college in State of Hawaii (proof of acceptance required); or
 - At a four year university or college in State of Hawaii (proof of acceptance required); or
 - Accepted in vocational-professional program in the State of Hawaii (proof of acceptance required)

Preference is given to:

- **Previous participants in any KEY Project Program**
- Applicants with a demonstrated financial need
- Applicants who are the first generation of immediate family to attend college

Grant Recipients (\$500/semester) must:

- Enroll as a full-time student with a schedule of at least 12 credits each semester
- Maintain a grade point average (GPA) of 2.5 or better or, for vocational/professional improvement program participants, a passing evaluation)

Incentive Education Grants in the amount of \$500/semester may also be disbursed for 4 semesters to applicants attending 4 year university/college in the State of Hawaii, provided that the applicant must be accepted at the 4 year university/college, as evidenced by an acceptance letter. Preference will be given to applicants who have previously received incentive grants for community college or vocational education as described above. Grants will be provided for two years so long as the recipient continues to:

- Enroll as a full-time student with a schedule of at least 12 credits each semester; and
- Maintain a GPA of 2.5 or better during the term of their award

Grants may be provided for longer than two years pending availability of funds & receipt of a new application.

Out-of-State Consideration: Incentive grants of \$500/semester may be disbursed each year to applicants attending a 2 year or 4 year college or vocational school located out of the state of Hawaii provided applicants must be accepted at the 4 year institution, as evidenced by an acceptance letter. Preference will be given to applicants who have received previous incentive grants for community college or vocational education at schools in the State of Hawaii. Grants will be provided for a period of two years provided recipients:

- Enroll as a full-time student with a schedule of at least 12 credits each semester; and
- Maintain a GPA of 2.5 or better GPA during the term of their award

Grants may be provided for longer than two years pending availability of funds & receipt of a new application.
